## Richard,

Here's some context and history of the MMS SAFE Awards.

MMS recognizes exemplary performance on the OCS each year by presenting SAFE awards at both a national and district level. The awards are given in four categories: High-activity operator, Moderate-activity operator, Production contractor and Drilling Contractor.

Definitions of High and Moderate activity are as follows:

- · A company that qualifies under the High Activity category would need to meet the following criteria:
- Product at least 10 MMBOE per year
- Operate a minimum of 1,000 in-service components during the year
- A company that does not qualify for the above category, may qualify for the Moderate Activity category if they meet the following criteria:
- o Produce at least 1 MMBOE per year
- o Operate a minimum of 100 in-service components during the year

The District SAFE Award process begins with a nomination from one or more inspectors to the district supervisory inspector. Criteria to be considered for nomination include MMS inspection results (components inspected, INCs issued), record of events (number and severity of major accidents, injuries, fires, etc), operational considerations (i.e. housekeeping, general condition of equipment, records, knowledge of contingency plans, general cooperation and attitude etc), and use of best available technology, including training of personnel on such technology. Candidates are discussed with the District Manager and a decision is made after confirmation of performance by the region.

The National SAFE Award process is a two-step process, beginning with a statistical analysis of companies' INCs received during the year. Each INC is weighted by adding potential for human injury and/or harm to the environment. The resulting "Safety Index" compares the safety performance of each company to that of others and to the average OCS company within their respective category.

The second step in the National SAFE Award is an in-depth discussion of the top candidates between MMS headquarters, region and district personnel to better understand section a company's compliance, knowledge of regulations, and attention to safety; operational complexity and challenges; and innovative approaches to existing and future operations. Only companies that show outstanding performance in each of the districts where they operate will be considered as a National SAFE Award Finalist.

For clarity sake, we will be receiving the following awards:

High Activity Award, New Orleans District SAFE Award - This citation will state it's
based on our overall performance of drilling and production activities for the New Orleans
District, including Marlin, Horn Mountain, Nakika, Pompano, Thunder Horse, Thunder Horse PDQ
rig, Horizon, Enterprise and Marianas. The New Orleans Drilling Contractor SAFE Award will be
given to a drilling contractor but I'm not aware of who that is and it will not be based our our drilling
performance.

High Activity Award, Hourna District SAFE Award - This citation will state it's based on
the performance of our production activities for the Hourna District, including Mad Dog, Holstein
and Atlantis. The Hourna Drilling Contractor SAFE Award will be given to a drilling contractor but
I'm not aware of who that is and it will not be based our our drilling performance.

The Rowan "Bob Palmer" will be given the Lake Jackson District Drilling Contractor SAFE Award also.

Hope this helps. Once you have reviewed this, we can talk again and decide how to send it out to the other VPs and Asset Managers to give some clarity.
