This Amendment is entered into effective as of the 1st day of January, 2007, by and between BP America Production Company (hereinafter referred to as "Company") and Wild Well Control, Inc. W I T N E S S E T H:

WHEREAS, by Contract No. BPM-04-00806 made and effective April 1, 2004, Company and Contractor entered into that certain Contract for "Work" (hereinafter referred to as "Contract").

WHEREAS, Company and Contractor desire to amend the Contract as more particularly set forth herein;

NOW THEREFORE, for and in consideration of the mutual covenants and agreements hereinafter provided, Company and Contractor agree to amend the Contract as follows:

2. Extend the Contract's expiration date a further five (5) years, from April 1, 2007 to April 1, 2012.
3. Contractor agrees to maintain current rates for a further two (2) years, from April 1, 2007 to April 1, 2009, at which time Contractor's rate sheet dated January 1, 2007 shall be inserted.

Except as changed by Amendment No. 1 the Contract shall remain in full force and effect as originally written.
