


Action by Consent of Directors, BP Exploration & Production Inc., (the "Company") effective December 10, 2007.





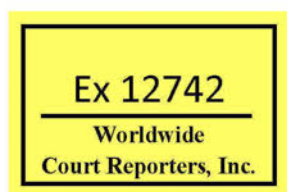
