**Subject:** Priority for Completion of BOP Work on the DDII

Eddy / Mike / Gavin,

This e-mail is to provide confirmation of our recently completed teleconference where the priorities for the DDII were established.

The priority for the DDII is to focus on having a tested stack available to be run with the HC connector in the cap and stack mode by putting the DDII BOP stack on the Horizon BOP stack - after removing the LMRP with the No 7 Anchor Winch.

It is recognized that by accelerating and prioritizing this option that resources will have to be pulled from working the second and third options (double preventer and ball valve option) to insure the Engineering and plans are fully vetted to be able to execute this option and "splash the stack" by Tuesday.

The critical path to this option is either delivery of the perforated / plugged riser joints or potential issues with completing the work on the BOP stack. The rig will be evaluating options over the night to take the BOP work off of the critical path by identifying potential resources that can be reallocated.
