- 1 The United States has focused on aspects of BPXP's governance and corporate structure. These aspects are **typical** of wholly owned subsidiaries.
- 2 If penalties on a subsidiary are higher when a parent company aids in a response, a parent is well-capitalized, or a subsidiary adopts typical governance practices, there would be **undesirable consequences**.
